A Review of Volunteer Engagement Standards and Best Practices from Nan Boyd, Council President

Standards are designed to ensure that any volunteer organization is effective, open, and accountable, and that volunteers have productive and supportive relationships with each other, with employees, and with other persons who interact with the organization.

Research on the most effective volunteer organizations shows that it is important to establish clear expectations, as done with our Council Responsibilities for Active Members and provide clear engagement standards to align with "best practices" for volunteer organizations.

Volunteer guidelines typically cover volunteer relationships, behaviors, communications, and organizational policies that govern volunteer service. Volunteers, just like employees, are expected to be respectful of ethnic, national, and cultural differences and to obey all applicable local, state, and federal laws.

- VMFA volunteers and staff work together in support of the VMFA mission. As an agency of the Commonwealth of Virginia, there are codes of conduct in place for staff.
- Staff and volunteers are expected to treat each other and visitors with respect, courtesy, and kindness.
- When providing suggestions or discussing concerns, this should be done in a considerate and appropriate manner.
- Understand that for personnel-related matters, there are due processes, confidentiality, and privacy guidelines in place by the Federal and Virginia Departments of Human Resources, which VMFA's Department of Human Resources follows.
- In all communications to each other and to VMFA staff (including email, phone calls and other forms), it is expected that all volunteers do so with respect and professionalism.

• For transparency and accountability, VMFA is bound by the Freedom of Information Act (FOIA) including volunteers' communications. In general, you should consider that everything is "FOIAble"; if you wouldn't feel comfortable with your email or voicemail message being quoted in a newspaper with your name, you shouldn't write it in an email or leave it in a voicemail.

More information on FOIA and other important guidelines and standards will soon be posted on The Council website www.vmfacouncil.org under Member Information. They will include such topics as Providing Positive Customer Service, Photography and Social Media Postings, Best Café Usage, Political Conversations and Emergency Procedures.


